HELD = A person must not deal with food that is Held without the approval of an authorised officer. Deal with food includes moving, altering or interfering in any physical manner whatsoever and includes entering into a transaction whereby the ownership of the food, or of any beneficial interest in the food, passes from one person to another. Severe penalties of up to 10 years imprisonment are prescribed under Section 9 of the *Imported Food Control Act 1992* for persons who deal with examinable food without authorisation.

RELEASED = Owner can move, distribute or sell the food while waiting for some test results. An authorised officer will assess the test results to determine pass or fail, then issue an Imported Food Inspection Advice. If the food fails, the owner may be required to retrieve or recall the food at their own cost.

Note: The owner is responsible for paying the laboratory costs.
